If and when the Contribution is accepted for publication in the Journal, the following terms and conditions shall become effective:

**Assignment:** Contributor hereby grants, transfers, and assigns to the Institute all right, title, and interest throughout the world in and to the Contribution and any revisions or versions thereof (for works of the United States Government, to the extent allowable by law), together with the copyrights therein and all exclusive rights comprised in the copyrights and remedies as afforded by law including, without limitation, the exclusive right: to register the copyright in the Institute's name; to reproduce, publish, transmit, and publicly distribute and display copies of the Contribution or excerpts there from in any format or media and by any method, device, or process now known or later developed; to prepare translations and other derivative works based on the Contribution; and to license, grant, transfer, assign, or convey to others any or all of the foregoing rights.

The Institute makes no guarantee that the Contribution will be published in the Journal. If, for any reason, the Contribution is not published in the Journal, then all rights in the Contribution hereby transferred and assigned to the Institute shall revert to Contributor, and this Agreement shall terminate and be of no further force and effect and neither party shall have any obligation to the other hereunder.

License to Contributor: the Institute grants back to Contributor the non-exclusive right to use all or part of the Contribution (after publication in the Journal) in any book or article written by the Author(s), provided that the copyright notice which appears on the issue of the Journal in which the Contribution is first published, and a full citation of the Journal, is affixed to copies of such book or article.

**Contributor's Duties:** (a) The manuscript of the Contribution shall be delivered to the Executive Editor of the Journal in the format required by the Institute. The Executive Editor may copyedit the Contribution as deemed necessary in order to prepare it for production and publication in the Journal. The Corresponding Author shall read and correct the proofs of the Contribution if forwarded and shall timely return them as directed. The Institute may charge to Contributor its proportionate share of the cost of changes in proofs which exceed 10% of the original proof costs. If corrected proofs are

not timely returned, the Institute may proceed with the production and publication of the Contribution as deemed appropriate. Color illustrations may be published within the Contribution at Contributor's request and expense.

(b) If the Contribution contains copyrighted material not owned by Contributor, then Contributor, at its expense, shall obtain written permission from the copyright owner, in a form acceptable to the Institute, to include such copyrighted material in the Contribution and to reprint it in the Journal, and shall deliver such written permission to the Executive Editor together with delivery of the manuscript of the Contribution.

(c) This Agreement must be signed by each Author (and Employer, if applicable), and delivered to the Executive Editor as a condition for publication of the Contribution in the Journal.

**Credit; Use Of Name and Likeness:** Each Author shall receive credit as an author of the Contribution when the Contribution is published in the Journal, the form and placement of which will be determined by the Institute. Each Author grants the Institute the right to use his/her name, likeness, biographical information, and professional affiliations in connection with the publication and promotion of the Contribution and the Journal.

**Warranties:** Contributor warrants and represents that: (a) Contributor is the owner of all right, title, and interest of every kind in and to the Contribution and the copyright therein, and has the full power and authority to grant, transfer, and assign all such rights to the Institute; (b) the Contribution has not been previously published and is the original work of the Author(s), except for such excerpts from works in the public domain or from copyrighted material owned by others and included in the Contribution with the written permission of the copyright owner; (c) the Contribution does not infringe the copyright or any other proprietary right of any party; (d) the Contribution contains no material that is defamatory, violates any right of privacy, or is otherwise contrary to law; (e) all statements in the Contribution asserted as facts are true or

based upon reasonable research for accuracy; and, (e) to the best of Contributor's knowledge, no formula or procedure in the Contribution would cause injury if used in accordance with the instructions and/or warnings contained in the Contribution. Contributor shall indemnify and hold the Institute, and its respective officers, trustees, directors, employees, agents, and licensees, harmless against any liabilities, damages, costs and expenses (including reasonable attorney fees and court costs)

resulting from any claim or the settlement of any claim, which, if true, would constitute a breach of any of Contributor's warranties and representations herein.

**Governing Law:** This Agreement constitutes the complete understanding of the parties and shall be interpreted according to the laws of the State of New York, regardless of the place of its execution.
